Location

Southampton is the largest city in the county of Hampshire, located approximately 80 miles (128 km) south-west of London, 20 miles (32 km) north-west of Portsmouth and 14 miles (22 km) south of Winchester. The city has a population of approximately 254,000 which includes over 32,000 full time students who are enrolled at the two universities; University of Southampton and Southampton Solent University.

The property can be found to the rear of the main Portswood Road commercial/retail parade, being accessed from a service access road between 189 Portswood Road and 40-41 Addis Square (Post Office).

Description

The property comprises ground floor office accommodation, which is currently split into two separate self-contained offices. The right hand side offers an entrance hallway, reception area, two offices, a meeting room, store room and WC. The left hand unit benefits from entrance hallway, reception/office, two further office rooms, two WC's and kitchen.

The accommodation also benefits from off road parking for 8 cars.

Accommodation

The accommodation has a total approximate Net Internal Area (NIA) of 2,045 sq ft (1,898 sq m)

EPC

We understand the property has an EPC rating of C - 69.

Planning

A new Use Classes Order (UCO) came into effect on 1st September 2020. Under the new UCO a new Use Class E was introduced to cover commercial, business and service uses. Use Class E encompasses A1, A2, A3, B1 and some D1 and D2 uses under the former UCO. We therefore understand that the premises benefit from Class E 'Commercial Business and Service' use within the Use Classes Order 2020.

Interested parties should make their own planning enquiries and satisfy themselves in this regard.

The property is available to let by way of a new full repairing and insuring lease for a term to be agreed at a commencing rent of £20,000 per annum exclusive.

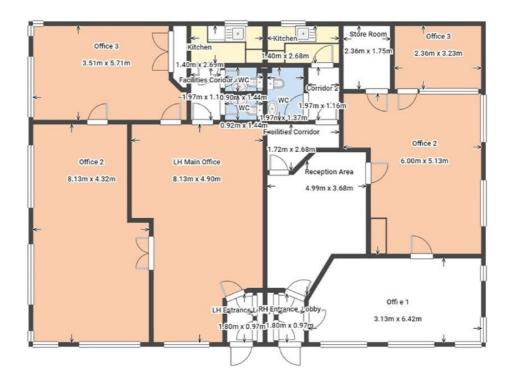






Floor Plan
